Development Application #2011-08 - Deck:

159-11 Harrison: "That we agree with the recommendations from Jim Walters, municipal planner and approve the development application submitted by Terry Deck to construct 3 Eco cabins on land legally described as SE 04-20-21-W2, subject to the following:

- The tourist camp shall have, within its boundaries, a buffer area abutting the boundary of the site which shall have a minimum depth of not less than 4.5 metres, which shall contain no buildings or structures and shall not contain any public roads, except those which connect a public roadway to the road system with the tourist camp.
- The space provided for roadways within the Tourist Camp shall be at least 7.5 metres in width
- The approval granted is on a maximum of 3 cabins, any additional cabins would be subject to an additional discretionary use application as it changes the intensity of the development.
- Approval from Regina Qu'Appelle Health Region on the septic disposal plan submitted."

- Cash-in-lieu of Municipal Reserve dedication in the amount of \$500.00, if deemed applicable by Community Services Branch of the Ministry of Municipal Affairs; and

That we are not aware of any land uses in the vicinity that would be incompatible with the intended use of the proposed site or any condition that would make the land unsuitable for the intended use; and

That we are not aware of any facilities that could be affected by the proposed development."
